EXPORT COMPLIANCE / END USE / END USER CERTIFICATION / STATEMENT

Subject: Compliance with United States Export Law and Regulations

It is the policy of TurbineWorks, LLC ("TURBINEWORKS") to verify the end use and end user of all products, services, technology, and software sold, shipped, transferred, or provided by TURBINEWORKS (collectively, "Products") to ensure compliance with U.S. sanctions and export control laws and regulations. As the Products you are purchasing are or may be for export outside the United States, please certify the following:

- 1) I (We) will not use or permit to be used, sell, resell, transfer, export or re-export any Products to any country or region which engages in armed conflict with the armed forces of the U.S. or to any other country or region to which shipment or trade is prohibited or restricted by U.S. sanctions or export control laws and regulations without prior U.S. Government authorization.
- 2) I (We) will not use or permit to be used, sell, resell, transfer, export or re-export any Products or other participation in any sale or export transaction involving our Products to Russia or Belarus.
- 3) I (We) will not sell, resell, transfer, export or re-export any Products for use in activities which involve the development, production, use or stockpiling of nuclear, chemical or biological weapons or missiles, nor use any Products in any facilities which are engaged in activities related to such weapons.
- 4) I (We) acknowledge that U.S. sanctions and export control laws and regulations prohibit the sale, resale, transfer, export or re-export or other participation in any sale or export transaction involving our Products with persons or entities that (a) are the target of U.S. sanctions, including persons and entities designated on the Specially Designated Nationals and Blocked Persons List or the Consolidated Sanctions List published from time to time by the Office of Foreign Assets Control of the U.S. Department of the Treasury ("OFAC"), (b) are named on the Entity List, Unverified List, Denied Persons List or Military End-User List published from time to time by the Bureau of Industry and Security of the U.S. Department of Commerce, or (c) the Debarred List published from time to time by the Directorate of Defense Trade Controls of the U.S. Department of State.
- 5) I (We) will abide by such U.S. export control laws and regulations for any and all Products purchased, received or transferred from TURBINEWORKS and will obtain any and all licenses or prior approvals which may be required by the U.S. Government prior to the export, re-export or transfer thereof.
- 6) I (We) acknowledge that TURBINEWORKS is subject, as applicable, to the provisions of the U.S. Export Control Reform Act and related Export Administration Regulations, the U.S. International Traffic in Arms Regulations, the Arms Export Control Act and the sanctions programs administered by OFAC.

- 7) I (We) agree not to act in any transaction involving Products acquired from TURBINEWORKS that may cause TURBINEWORKS to violate such sanctions and export control laws and regulations.
- 8) I (We) warrant that the Products are being purchased for use on commercial aircraft for civil commercial uses and not for military purposes or for operations permitting such aircraft to fly to any prohibited or restricted country or for transfer to, or transfer of possession of or operational control, to any prohibited or restricted country.
- 9) I (We) agree that the requirements in Number 1-6 above shall survive the completion, early termination, cancellation or expiration of any purchase order, agreement or contract with TURBINEWORKS.
- 10) Should I (We) become aware of any violation or suspected violation of the terms of this certification, I (We) will immediately notify the TurbineWorks Export Compliance Group of the facts and circumstances and will fully cooperate with any investigation of same.
- 11) I (We) agree that this certification applies to the company listed below and includes all subsidiaries and affiliated companies and is valid indefinitely from the date of its acceptance by TurbineWorks.
